

August 15, 2022

The Kingsley City Council met in regular session on August 15, 2022. Those present were Mayor Bohle, Councilmen Kremer, Jasperson, Rolling, Beelner and Bohle.

The agenda was approved on motion by Beelner, seconded by Bohle, all voted aye, motion carried.

Public Forum: Jacob Hagan and Cash Howe were present to discuss a dog bite situation in their neighborhood. Two dogs bit a neighbor, police and ambulance were called to assess the situation. A letter will be served to the dogs' owners to remove the animals from the city limits within seven (7) days from receipt of letter.

Brandon Sitzmann, Fire Chief, discussed problems with security at the fire station during events. Mayor Bohle will talk with the Volunteers.

Ordinance #266 (no trees in city parking) was presented for the third reading. Ordinance was introduced by Bohle, seconded by Beelner. Motion to approve by Bohle, seconded by Beelner. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye, motion carried. Motion to adopt by Bohle, seconded by Beelner. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye, motion carried.

Ordinance #267 (raise water rate, minimum will increase from \$11.00 to \$13.00 for the 1<sup>st</sup> 1000 gallons; increase from \$1.25 to \$2.50 per 1000 gallons up to 10,000 gallons; then \$3.50 per 1000 gallons after 10,000 gallons). Motion by Rolling, seconded by Jasperson to approve first reading. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried.

Ordinance #268 (raise sewer rate from \$21.00 to \$25.00 per month). Motion by Rolling, seconded by Jasperson to approve 1<sup>st</sup> reading. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried.

Garbage rate will remain at \$13.50 per month

Ordinance #269 (raise landfill rate from \$14.00 to \$16.00 per month). Motion by Rolling, seconded by Jasperson to approve 1<sup>st</sup> reading. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried.

Mayor Fischer of Menville visited with the Council about the possibility of sharing a building/nuisance inspector with Menville and other nearby cities with some possible changes to the city's contribution. Councilman Jasperson suggested that a committee be formed with a member from each participating city. It was the consensus of the Council to agree with city budget costs of around \$6,000.00/year. This will be discussed again on September 6<sup>th</sup>.

Ordinance #270 (Adopt a new Chapter 160 re: floodplain management). Motion by Rolling, seconded by Kremer to approve Ordinance #270. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried. Motion by Rolling, seconded by Kremer to waive the three readings. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried. Motion by Rolling, seconded by Kremer to adopt Ordinance #270. Roll call vote: Rolling, aye; Beelner, aye; Kremer, aye; Jasperson, aye; Bohle, aye. Motion carried.

Motion by Jasperson, seconded by Kremer to approve Doosky's liquor license, all voted aye, motion carried.

Motion to adjourn by Jasperson, seconded by Bohle, all voted aye, motion carried.
